

ONLINE HOTEL REPRESENTATION AGREEMENT

THIS EXCLUSIVE AGREEMENT is made as of _____ between GDS Hotels Private Limited, **WZ 73, B1 Janakpuri , Near Janakpuri East Metro Station, New Delhi – 110058, India** and

WITNESSETH

Whereas GDS Hotels Private Limited desires to engage **Hotel** as its reservations representation in accordance with the terms and conditions of, and subject to the limitations contained in, this Agreement.

Now, therefore GDS Hotels Private Limited and **Hotel** covenant and agree as follows:

- A. GDS HOTELS PRIVATE LIMITED is a Premier Service Agent of ReservHotel International, USA and is operating an international hotel reservation system utilizing Global Distribution Systems ("GDS"), the Pegasus Online Distribution Database ("ODD"), internet hotel reservation programs, and proprietary computer programs (all four collectively, the "System"); a purpose of the System is to interface, on a competitive basis, travel agents and others using the GDS or internet with hotel properties;
- B. GDS Hotels Private Limited is specialized to Market Hotels in Independent online Travel Portals, Domestic & International Online Portals, Travel Agents, Travel Consolidators, Hotel Consolidators etc. & responsibly manages Rates, Availability, Rate Parity, allocation, display information, Customer Issues/ Complaints etc. Hotel grants access to market & manage Online Travel Portals, GDS, Consolidators, DMCs on its behalf.
- C. GDS HOTELS PRIVATE LIMITED currently makes the System available to international, national and regional hotel groups operating under various trade names; GDS HOTELS PRIVATE LIMITED is able to differentiate each customer's business;
- D. GDS Hotels Private Limited wishes to utilize the System on behalf of itself and their clients Hotel Properties and GDS HOTELS PRIVATE LIMITED wishes to make the System available to **Hotel** and their other Hotels;
- E. GDS Hotels Private Limited will distribute the Hotel through the GDS System & Online Travel Portals throughout the India & International.
- F. Hotels will provide the Nett & non Commissionable Contracted rates to GDS Hotels Private Limited according to seasons & off seasons through the email, where GDS Hotels Private Limited will add up the margin & sell the hotels to respective GDS, ODD Pegasus, and Online Travel Portals & Travel Agents as per clause "D". Such added margin will be the commission for GDS Hotels Private Limited.
- G. GDS Hotels Private Limited will provide Credit Card Guarantee in case of direct payment required to be collected by the guest at the time of check out. Such Credit Card needs to be verified by the hotel upon receipt of booking. In case such Credit Card declines; hotel has to inform such booking immediately through the email.
- H. In case of No Show, hotel has to charge the penalty charges from the Guest Credit Card. If Guest Credit Card declines hotel will bear such bookings and no charges will be invoiced to GDS Hotels Private Limited.
- I. Hotel will pay the commission on No show bookings where hotel will be able to collect the charges. If any case hotel will not be able to charge such booking, hotel has not to pay commission for such booking to GDS Hotels Private Limited
- J. Invoice should be cleared in 15 days of receipt from GDS Hotels Private Limited.
- K. GDS Hotels Private Limited can invoice & take Payment from the Online Travel Companies, Travel Agents, Consolidators on behalf of hotels. Such payment will be paid to the hotel as per Contracted Rates within 30 days.
- L. This Agreement is valid upon signed by both parties for the period of 2 years and can be extended upon mutual consent. This Agreement can be terminated after 60 days written notice by either party.
